# REGISTRATION SPECIALIST DUTIES

### **Duties**

#### 2016 EJ Manual Pgs. 16, 77

- All duties of a Team Judge assigned to the Registration Duty Station.
- Monitor and mentor Team Judges serving at the Registration Duty Station.
- Perform hourly audits of the Voter Registration
   Applications and the New Registrants Green Roster.
- Lead opening and closing of the Registration Duty Station.

# Opening the Registration Duty Station

- Retrieve the Registration Bag from the Blue Supply Case and place materials at the table(s) designated as the Registration Duty Station.
- Retrieve 2-3 Greeter's Lists (# depending on needs of polling place) from the Head Judge.
- Work with Team Judges to resolve any questions they may have about registration.

# Monitoring & Mentoring Team Judges

### **2016 EJ Manual Pg. 121**

- Why is mentoring Team Judges important?
- Observe your team completing their duties.
- Provide constructive feedback using CPR.
  - Constructive vs. unconstructive feedback.
  - Compliment, Positive correction, Review.
    - For example...

# **Hourly Audits**

- If voter traffic at station is manageable. Don't keep a voter waiting.
- Voter Registration Applications (VRAs) and New Registrants Green Roster.
  - Take note of any errors and use these as teaching moments for Team Judges.

### Closing the Registration Duty Station

#### 2016 EJ Manual 147, 148, and 150

- Election Day Registration Envelope
  - Place in envelope:
    - Precinct List of Persons Vouching
    - Record of Attempted Registration
    - Bundles of New Registrants Green Roster page & corresponding VRAs
  - Complete front.
  - Seal.
  - Four election judges sign over the seal.
- Provide total # of Election Day registrations to Head & Assistant Head Judge (for Results Tapes and Voter Statistics Worksheet).

# MN REGISTRATION/VOTING ELIGIBILITY

### MN Registration/Voting Eligibility Requirements

### 2016 EJ Manual Pg. 78

- 18 years old by Election Day.
- Citizen of the United States.
- Minnesota resident for 20 days.
- If convicted of a felony, finished with all parts of felony sentence including probation or parole.
- May vote while under guardianship unless court order has specifically revoked voting rights.



# **Election Day Registration Process**

#### **2016 EJ Manual Pg. 78**

- 1. Ask voter for name.
- Check for name on Absentee Election Day Registrants for Polling Place list.
- 3. Ask voter for address.
- 4. Confirm voter isn't already registered using the Greeter's List.
- Confirm voter is in the correct polling place using the Precinct Finder.
- 6. Have voter complete top of Voter Registration Application (VRA).
- 7. Verify voter's proof of residence and complete bottom of VRA.
- **8. Print voter's name, address, and date of birth** on New Registrants Green Roster.
- 9. Have voter sign Green Roster.
- 10. Issue a Voter's Receipt.

# Serving Homeless Voters

#### 2016 EJ Manual Pg. 93, 163

- Voter writes a description of where they usually sleep in box 4 of the voter registration application.
- Judge verifies that the location described is within the precinct.
  - Precinct Finder, call to HQ.
- Voter provides proof of residence (most likely a voucher).

## Serving Voters with Multiple Residences

### 2016 EJ Manual Pg. 93, 163

- A voter may only declare one residence for the purposes of voting. They may register and vote in only one place.
- It is up to the voter to make the determination of their principal place of residence.

- Always complete W, P, SD, and Initials fields.
- Can use old forms, see example on top.
- For out-of-state ID's, write state.

# PROOFS OF RESIDENCE REVIEW

### **Proofs of Residence**

- To register on Election Day in Minnesota, think: "the voter needs proof of residence,"
   NOT "the voter needs photo ID."
  - Some proofs don't involve photo ID at all.

  - Pg. 85 (Lists of proofs)
  - Pg. 164 (Registration Requirements document; visual examples)

# Proofs of Residence "Stand-alone"

- Valid MN Driver's License, MN Learner's Permit, MN ID card, or receipt for any one of these.
  - If card says "status check"... (2016 EJ Manual Pg. 85)
- Tribal ID card with name, current address, signature, and picture issued by the tribal government of a tribe recognized by the Bureau of Indian Affairs.

## Proofs of Residence – "Combo"

#### <u>COLUMN 1 – Photo ID with current name</u> (can be expired)

- Driver's license, state ID card, or learner's permit issued by any state
- United States Passport
- United States Military or
   Veteran ID (new in 2016) card.
- Tribal ID card with name, signature and photo of the voter
- Minnesota university, college, or technical college ID card
- Minnesota high school ID card

# COLUMN 2 – Approved document with current name and current address (can be shown on portable electronic device)

- Residential lease or rental agreement (must be valid through Election Day).
- Current student fee statement.
- Bill, account statement, or start of service notification, due or dated within 30 days of Election Day for:
  - Phone (landline, cell, VOIP, etc.)
  - TV (cable, satellite, etc.)
  - Internet services
  - Solid Waste or sewer services
  - Electric, gas, or water
  - Banking or credit card
  - Rent or mortgage payments

### Proofs of Residence – "Other"

- Voter Voucher
  - Voucher Form
  - Limit of 8 (track on Precinct List of Persons Vouching; 2016 EJ Manual Pg. 89)
  - Someone who registers on Election Day who is vouched for can't vouch for someone else on that same day.
- Employee Voucher
  - Voucher Form
  - Must show proof of employment at a residential facility in the precinct (employee ID; name on employee list; signed statement).
  - Can vouch for an unlimited number of residents who live at the facility in which they work.
- Notice of Late Registration
- Valid registration in same precinct
- College student ID with name on Student Housing List

- New in 2016: space for voucher to print name.

Confidentiality Notice: Your exact date of birth, email address, and any ID number you give (Minnesota driver's license, state ID or last four digits of social security number) are private. Only election officials and other authorized government agencies may access this information. Election officials use your exact date of birth and ID number to confirm your identity with the Minnesota Department of Public Safety or Social Security Administration. If you have an ID number but refuse to give it, your application may be incomplete and you may have to apply again or show proof of residence before you can vote. Election officials ask for your email so they can contact you about your application. Also, the Office of the Secretary of State may email you (or contact you another way) about voting and elections, or ask for public input on voting or election-related issues. The rest of the data on your application is public when used for elections, political, law enforcement or jury selection purposes. If you need to keep your contact data private because of personal safety concerns, call 1-877-600-8683.
